A joint workplace of Charles University in Prague and the Czech Academy of Sciences, CERGE-EI provides a world-class graduate education in English and produces cutting-edge research. CERGE-EI holds research seminars and public lectures several times each week, delivered by leading economists from Europe and North America.

US-style PhD Degree

The US-style PhD program is designed for outstanding students who desire a rigorous graduate education in economics at a prestigious research institution. It has a permanent charter issued in the United States, and is fully accredited in the Czech Republic. Graduates thus receive both a US and a Czech PhD degree.

International Student Community

Our students come from almost three dozen countries on five continents and have a wide variety of backgrounds, including degrees in economics, mathematics, international relations, physics, computer science, engineering, business or sociology.

Full Tuition Waivers and Stipends

Almost all PhD students receive full scholarships, including tuition waivers and living stipends, and can thus focus on their studies. Students in good academic standing retain their scholarships for a full four yeas, after which CERGE-EI provides teaching and research opportunities, with appropriate stipends, until their dissertations are completed.

Study Stays at Top US and European Universities

Students are supported to spend a semester or academic year on mobility, to conduct part of their dissertation research working with experts in their fields at leading universities in Western Europe and North America.

Research Opportunities

PhD students often join in faculty research projects as full partners. They are also encouraged to publish their research work and regularly receive conference travel support.

Individual Approach

Thanks to the relatively small size of the institution, our students are able to discuss their research projects and ideas in depth with faculty members. They also receive personal attention from the Study Affairs Office that helps them with everything from visas to housing. The Academic Skills Center helps students to develop their written and oral communication skills.

Eligibility Criteria

- Strong background in mathematics is an advantage.
- Sufficient proficiency in English to read, write and fully understand study material is necessary.
- Previous education in economics is welcome, but not required.
- Masters degree or equivalent.

Documents Required

- Online application form
- Curriculum vitae
- Statement of motivation
- Certified copies of BA and MA diplomas and transcripts
- Two letters of recommendation
- Optional: TOEFL, IELTS, or other certified English language exam score / GRE or other proficiency test score

Application Deadline

- April 30

Admission Process

Documents are evaluated by the CERGE-EI Admissions Committee. Students may be admitted directly or invited to the summer preparatory semester for intensive training in intermediate microeconomics, macroeconomics, and mathematics. This takes place in Prague, Czech Republic in July and August.

Number of Admitted Students

Approximately 30 students admitted each year.
